RENEWED FOCUS

While institutions such as SK Arts represent steady anchors of stability, history tells us that we are not defined by our moments of ease but by how we respond to change. Stepping into my new role as CEO of SK Arts almost halfway into the fiscal year, I recognized this transitory period for the agency as an opportunity not only to build on my successor's work, but to redefine ourselves as an institution that authentically reflects Saskatchewan's growing diversity of cultures, voices and experiences in the communities we serve.

This time is about representation—embedding equity and inclusivity into the core of our mission, leadership, daily operations, preservation of culture and longevity amid global challenges.

This year we launched the first issue of the beautiful *ARTS Saskatchewan* magazine. Packed with more than a dozen stories of focus, history and hope of some of our celebrated established and emerging artists, the magazine has profoundly executed our vision to capture and catalogue Saskatchewan artists, their artistic range and the impact and inspiration of their work in all sectors and aspects of life.

We have found ourselves at a critical moment that has brought into sharp focus the fragile ecosystem that sustains the arts. Despite our unwavering commitment to supporting creativity, community and cultural expression, there has never been a greater need for the arts to thrive, to reflect to us who we are, to capture the essence of what makes us proudly Canadian and proudly Saskatchewanian. The arts are needed to bolster our youth and create a sense of place for them here, at home.

SK Arts consulted with our Professional Arts Organization Program (PAOP) organizations to speak directly with the community about their position and needs. The report will be available later this year to inform necessary changes to PAOP and provide support as efficiently as possible to preserve the legacy of the arts in Saskatchewan.

We launched the Arts of Celebration event, a new way to recognize artists and their fantastic work. The campaign honoured seventy-four artists, arts leaders, organizations and festivals at varied career stages, selected by the community and celebrated in conviviality by stakeholders at all levels.

As we band together and rely on the resilience of the arts sector, we have much to be proud of and even more work to do. I look forward to carrying on the legacy with which I have been entrusted.

Strategic Planning

Concluding our second full year of work towards SK Arts' objectives in the 2023/24 – 2028/29 strategic plan, and while we look forward to new tactical ways to execute our strategy over the next few years, below are a few notable milestones delivered this year. It is important to note that as the agency transitioned its leadership and staff through a series of retirements, several projects did not progress in the timelines originally planned. As a small organization, the transitions impacted available resources and institutional knowledge.

- In the first curated call since SK Arts updated the Permanent Collection's acquisitions process, the agency focused on acquiring artwork in 2024 by Indigenous, underserved, LGBTQ2S+, and disability artists. The selection considered diversity in artistic disciplines and media, including craft, regional representation across the province, and ways to increase the collection's accessibility for the people of Saskatchewan.
- After executing the new Arts of Celebration event, which transfers the power of arts recognition to the community and celebrated all artistic disciplines in its initial year (2024), we are narrowing the lens on those disciplines in each celebratory year in 2025 through 2027, recognizing music and theatre in 2025, visual and literary in 2026, and dance, media and multidisciplinary disciplines in 2027.

EXTEND THE REACH OF SK ARTS' PROGRAMS


- SK Arts, through the hiring of the new program consultant with equity and inclusion focus, conducted several in-situ information sessions and grant-writing workshops across the northern and southeastern regions of the province to educate and provide support to artists.
- SK Arts invested in a significant infrastructure upgrade to the Permanent Collection database to increase public access; developing a method to manage image access permissions for the online catalogue, enabling authorized users to retrieve images as needed.
- SK Arts partnered with 19 organizations, galleries and museums in loans across the province that feature artwork from the Permanent Collection, including St. Paul's Hospital in Saskatoon, to provide Wilf Perreault's Hiding Places, a floor-to-ceilingsized painting, on long-term loan to patients, staff and visitors.
- A partnership between SK Arts and Dunlop Art Gallery in Regina featured eight newly acquired artworks on loan for the exhibition, Of A Place, at the Sherwood Branch Gallery. Its success resulted in a partnership to annually feature artwork from the SK Arts Permanent Collection in exhibitions.

ADDRESS SYSTEMIC BARRIERS TO Inclusivity, diversity, equity and accessibility

 In the winter of 2024/25, SK Arts held a series of community consultations with Professional Arts Organization Program (PAOP) organizations to document concerns and recommendations as part of a comprehensive review of the PAOP program that will be launched in the 2025/26 fiscal year.

CHAMPION SASKATCHEWAN ART AND ARTISTS

 SK Arts launched a new arts magazine, ARTS Saskatchewan, a new way to showcase artists and their work more intimately, supported by SK Arts funding.

Financials

Management of the Saskatchewan Arts Board (the Board) is responsible for the preparation and presentation of the financial statements and other financial information reported by the Board of Directors. This obligates management to use its best judgment in preparing and presenting financial information in accordance with established Board of Directors policy and principles which are acceptable to the accounting profession.

The Board has established a system of internal controls to govern the management and accountability of financial resources entrusted to it. Management relies upon the system of internal controls to ensure that financial transactions are accurately recorded on a timely basis, are properly approved and result in reliable financial statements. It is, therefore, responsible for all amounts reported therein, including valuations determined externally by specialists. Management believes that the existing system of internal control provides a reasonable assurance that the assets are safeguarded and that the financial records are reliable for preparing financial information and maintaining accountability for assets. Management is responsible for providing reasonable assurances to the Board and the general public through the Legislature that the Board's financial information satisfies standards of validity and reliability. This requires that quantitative data be based on relevant parameters of measurement that are consistently applied over time.

Management provides the Board with the necessary information for it to make governance decisions at the highest meaningful level in connection with the objectives articulated in *The Arts Board Act, 1997*. Management discharges its responsibility for financial information under the stewardship of the Board and its Finance Committee.

In accordance with Article 28 of *The Arts Board Act, 1997* the Board's financial statements are audited annually by the Provincial Auditor or any other auditor or firm of auditors appointed by the Lieutenant Governor in Council. The Finance Committee is available to meet with the designated auditors as required.

INDEPENDENT AUDITOR'S REPORT

TO: THE MEMBERS OF THE LEGISLATIVE ASSEMBLY OF SASKATCHEWAN

Opinion

We have audited the financial statements of the Saskatchewan Arts Board, which comprise the statement of financial position as at March 31, 2025, and the statement of operations and accumulated operating surplus, statement of changes in net financial assets, statement of remeasurement gains and losses, and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Saskatchewan Arts Board as at March 31, 2025, and the results of its operations, its remeasurement gains and losses, changes in net financial assets, and its cash flows for the year then ended in accordance with Canadian public sector accounting standards.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Saskatchewan Arts Board in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian public sector accounting standards for Treasury Board's approval, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Saskatchewan Arts Board's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Saskatchewan Arts Board or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Saskatchewan Arts Board's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit
 procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of
 not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery,
 intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Saskatchewan Arts Board's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and based on the audit evidence obtained,
 whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Saskatchewan Arts Board's ability to
 continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the
 related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the
 audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Saskatchewan Arts Board to
 cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS March 31, 2025

1. PURPOSE AND AUTHORITY

The Saskatchewan Arts Board (the Board) was established pursuant to *The Arts Board Act*. It has been continued under *The Arts Board Act*, 1997 (the Act). It provides funding and support to the arts for the benefit of all people in Saskatchewan. The Act continues the Saskatchewan Arts Board Fund through which all financial transactions are conducted which pertain to fulfilling the purposes of the agency as indicated in the Act.

2. SIGNIFICANT ACCOUNTING POLICIES

These financial statements are prepared in accordance with Canadian Public Sector Accounting Standards issued by the Public Sector Accounting Board. The significant policies are as follows:

a) Collections

The Board maintains a collection of artworks and related archives in all forms in order to inform, enlighten, and enhance the lives of present and future generations. Works in the collection are acquired through purchase, commission, donation, or bequest.

- i) Permanent Collection purchases are charged at cost as an expense in the Statement of Operations and Accumulated Operating Surplus in the year of purchase.
- ii) Donated works of art and archives for the Permanent Collection are recorded as revenue at their fair market value at the time of donation with a corresponding charge to expenses in the Statement of Operations and Accumulated Operating Surplus.

b) Tangible Capital Assets

Leasehold improvements, equipment, and furnishings are recorded at cost less accumulated amortization. The net book value of these capital assets is detailed in Note 14. Tangible capital assets are amortized on a straight-line basis over their estimated useful lives which are as follows:

Electronic equipment 4 years
Other equipment 6 years
Furnishings 10 years
Leasehold improvements Life of the lease

Tangible capital and other non-financial assets are accounted for as assets by the Board because they can be used to provide Board services in future periods. These assets do not normally provide resources to discharge the liabilities of the Board unless they are sold.

c) Restricted Assets

Designated Assets: the Board periodically restricts amounts from cash to be allocated for specified purposes. In restricting these amounts, the Board takes into account the amounts and stated preferences of contributors. These amounts are not available for other purposes without the approval of the Board of Directors.

d) Expenses

Grants are recognized in the year in which they are budgeted and approved by the Board, the applicant has met the eligibility criteria, and the amount of the grant can be estimated. All other expenses are recognized in the year in which they are incurred.

e) Cash

Cash consists of interest-bearing money on deposit with the bank. The interest rate during the year was 3.05% to 5.20% (2024: 4.70% to 5.20%).

f) Use of Estimates

The preparation of financial statements in accordance with Canadian generally accepted accounting principles for Public Sector requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Assumptions underlying asset valuations are limited by the availability of reliable comparable data and the uncertainty of predictions concerning future events. The inherent uncertainty involved in making such estimates and assumptions may impact the actual results reported in future periods. Differences are recorded in current operations when identified.

The primary measurement uncertainty arising from the use of estimates which may affect reported amounts relates to the values of accounts receivable, and tangible capital assets.

g) Revenues

Revenues are recognized as they are earned and measurable.

Government transfers are recognized in the financial statements in the period in which the transfer is authorized, eligibility criteria are met and reasonable estimates of the amount can be made.

Deferred revenue represents user charges and other fees which have been collected, for which the related services have yet to be provided. These amounts will be recognized as revenue in the fiscal year the services are provided.



NOTES TO THE FINANCIAL STATEMENTS March 31, 2025

h) Investments

The Board's funds have been invested into an assortment of pooled funds. These pooled funds include Canadian, U.S., international and emerging markets equities; bonds; and cash and cash equivalents. Such funds are valued daily based on the closing prices of the securities held in the funds. All investments are valued at fair value. Investment income is recognized when earned and includes pooled fund income and realized gains or losses on the sale of investments.

i) New Accounting Standards

The Public Sector Accounting Board of Canada has issued the following new accounting standards:

- The Conceptual Framework for Financial Reporting in the Public Sector (effective April 1, 2026)
- Financial Statement Presentation (section 1202—effective April 1, 2026)

The Arts Board has not adopted the above accounting standards and is currently reviewing their potential impact on the financial statements.

3. PENSION PLAN

Employees make contributions to the Public Employees' Pension Plan, a defined contribution plan. Funding requirements are established by *The Public Employees' Pension Plan Act*. During the year, the employee contribution rate increased to 8.0% (2024: 7.5%), and the employer contribution rate increased to 8.5% (2024: 8.0%) for in-scope employees. The out-of-scope employee contribution rate increased to 8.0% (2024: 7.5%) and the employer contribution rate increased to 8.5% (2024: 8.0%). During the year, the Board's total contributions were \$128,661 (2024: \$119,141) and are included in Salaries and benefits in Note 8.

4. FAIR VALUE OF FINANCIAL INSTRUMENTS

The Board's significant financial instruments consist of cash, investments, accounts receivable, and accounts payable. As described in Note 2h, the investments are carried at fair value. The fair values of the other financial instruments approximate their carrying value due to their short-term nature.

The investments are classified using a hierarchy that reflects the significance of the inputs used in determining their measurements.

Under the classification structure, financial instruments recorded at unadjusted quoted prices in active markets for identical assets and liabilities are classified as Level 1. Instruments valued using inputs other than quoted prices included in Level 1 that are observable for the asset or liability either directly or indirectly are classified as Level 2. Instruments valued using inputs that are not based on observable market data are classified as Level 3.

5. ASSESSMENT SERVICES

The Board has entered into an agreement with Access Copyright Foundation to provide assessment and program delivery services on their behalf. In this case the Board is acting as an agent and only records the net revenue from these activities in Statement 2. During 2025, the Board convened review panels leading to the recommendation of 86 Access Copyright Foundation grants (2024: 82 grants). Net revenues earned by the Board in 2024-25 are \$48,500 (2024: \$49,250).



6. CONTRACTUAL OBLIGATIONS

Operating lease

The Board leases office space in Regina and Saskatoon and storage space for its Permanent Collection in Regina. The Regina office space lease expires January 31, 2029, and the Saskatoon office space lease expires August 31, 2026. The future minimum lease payments are:

7. CONTRACTUAL RIGHTS

The Board has entered into contracts related to the art rental program that the Board expects to generate economic resources from in the form of future revenue in the amount of \$158,428 over the next three fiscal years. The Board has entered into one contract related to assessment services that the Board expects to generate economic resources from in the form of future revenue in the amount of \$24,250 in 2025/26.

During the year, the Board purchased art objects totaling \$77,763 (2024: \$79,866) for the Permanent Collection. In addition, art objects of \$17,740 (2024: \$114,270) were donated to the Collection and art objects of \$0 (2024: \$0) were de-accessioned. In January 2002, the Permanent Collection was appraised by members of the Professional Art Dealers Association of Canada and assigned a value of \$2,903,173 on the basis of market value. In 2025, 51 objects (2024: 213 objects) were appraised at a value of \$897,375 (2024: \$603,610). With the addition of 2025 acquisitions, the appraised value of the Collection is increased to \$7,895,052 (2024: \$7,394,175). The remaining objects in the Collection will be appraised in due course.

10. INVESTMENTS

Rates of return are declared by the investment manager each quarter. Any earnings or loss on investments are recognized at the end of the month based on statements from the investment manager. Fees consist of custodial fees and management fees. Custodial fees are incurred monthly while management fees are incurred on a quarterly basis. During the year, the Board consigned \$0 (2024: \$0) to the Investment Fund and withdrew \$169.652 (2024: \$145.992).

2025 earnings from investments was \$775,205 (2024: \$935,251) and bank interest was \$166,535 (2024: \$177,585) for total earnings of \$941,740 (2024: \$1,112,836).

a) Endowment Fund

During March 2015, in accordance with *The Arts Board Act*, 1997, Article 26, the Board of Directors established an endowment fund of \$5,000,000 designated for the benefit of arts and artists in Saskatchewan. The Board stipulated that, except under exceptional circumstances, only interest received from the Endowment Fund is to be allocated to initiatives in support of the arts in Saskatchewan.

b) Prince Edwards Arts Scholarship Fund

In 2004, the Board received \$30,000 from the Provincial Secretary designated for the Prince Edward Drama Scholarship Fund. This fund is designated to provide funding to Saskatchewan students who are studying in arts programs. The Board stipulated that, except under exceptional circumstances, only interest received from the Prince Edwards Arts Scholarship Fund is to be allocated to this initiative. The amount of interest allocated must be less than 3.5% of the previous year's capital.

c) Fred Mennie Fund

In 1999 the Board designated \$20,884 for the Fred Mennie Fund. The Board stipulated that, except under exceptional circumstances, only interest received from the Fred Mennie Fund is to be allocated to this initiative. The amount of interest allocated must be less than 3.5% of the previous year's capital.

- b) The benchmark return is the Board's target rate of return for its investments. The benchmark return is based on the performance of the Board's planned investment portfolio.

The funds are invested based on the Board's investment policy. The Board pays investment management fees and custodial fees for these services.

12. FINANCIAL RISK MANAGEMENT

The nature of the Board's operations result in a statement of financial position that consists primarily of financial instruments. The risks that arise are credit risk, liquidity risk, and market risk (consisting of interest rate risk, foreign exchange risk and equity price risk).

Significant financial risks are related to the Board's investments. These financial risks are managed by having an Investment Policy that provides guidelines to the Board's investment manager for the asset mix of the portfolio regarding quality and quantity of fixed income and equity investments. The asset mix helps to reduce the impact of market value fluctuations by requiring investments in different asset classes and in domestic and foreign markets. The Board reviews regular compliance reports from its investment manager as to its compliance with the Investment Policy.

a) Credit Risk

Credit risk is the risk that a party owing money to the Board will fail to discharge that responsibility. The Board is exposed to minimal credit risk from the potential non-payment of accounts receivable.

Credit risk within investments is primarily related to fixed income pooled funds. It is managed through the Board's investment policy that limits these fixed term investments to those of high credit quality (BBB is the minimum rating for bonds and the minimum quality rating of any short-term note is R-1 Low as rated by DBRS). The maximum credit risk the investments is exposed to at March 31, 2025, is limited to \$3.04 million (2024: \$2.6 million) which represents investment in bonds; and cash and cash equivalents.

b) Liquidity Risk

Liquidity risk is the risk that the Board will encounter in meeting obligations associated with financial liabilities. The Board is exposed to low liquidity risk. This is managed through prudent financial management and oversight.

c) Market Risk

Market risk is the risk that arises from changes in the value of financial instruments. Values can be affected by changes in interest rates, foreign exchange rates and equity prices. Market risk primarily impacts the value of the investments.

Interest rate risk

Investments are exposed to changes in interest rates in their fixed income investments. Duration is a measure used to estimate the extent that market values of fixed income instruments change with changes in interest rates. Using this measure, it is estimated that an increase of 100 basis points in interest rates would decrease net assets by \$0.2 million, representing 7.27% of the \$2.7 million fair value of fixed income investments.

Foreign exchange

Investments are exposed to changes in the U.S. dollar exchange through their U.S. Equities. Also, they are exposed to international currencies through their International and Emerging Markets Equities. As at March 31, 2025, the investments' exposure to U.S. Equities was 17.5% (2024: 19%), their exposure to International Equities was 17.5% (2024: 18%) and their exposure to Emerging Markets Equities was 3.3% (2024: 3.4%).

Equity prices

Investments are exposed to changes in equity prices in Canadian, U.S., international and emerging markets through their equity investments. Equities comprise 62% (2024: 65.2%) of the carrying value of the investments. The Investment Policy limits the investment in equities to no more than 25% of the total market value of the fund in any one index-defined corporate group.



13. CONTINGENT LIABILITIES

The Arts Board has been named as a co-defendant in one claim that was served prior to 2014. As at March 31, 2025, the likelihood of resolution of this claim against the Arts Board is not determinable.
