This year's annual report introduces the theme *PART* of *Our Lives*, which we have adopted to highlight the importance of the arts in the daily lives of all Saskatchewan people. Regardless of where we live, our culture or our age, the arts inspire us and make the places we call home unique. The value of the arts is felt in our award winning galleries, community festivals, theatres, the work of our professional artists and also in the songs that we sing, and in the stories that tell us where we've been and where we are going. Art is *PART* of it all!

PART OF OUR PROVINCE

Over the past year the Board has continued to work towards making art and professional artists more accessible to individuals and communities. The much appreciated increase in funds from the Government and the people of Saskatchewan has allowed us to support more work across the province and benefit more citizens than ever before.

For example, the *Art At Work* initiative placed artists in ten Regina workplaces to share their creative skills with workers across a wide range of disciplines. Many of the participants from these residencies reported that emphasizing creativity increased their productivity, their energy level and generally made their work experiences more positive.

The Board has moved forward in its commitment to the Indigenous communities of Saskatchewan by creating the Indigenous Bridging Arts program, the second in a suite of programs that support Indigenous arts and artists. These significant programs have helped to create opportunities for the Indigenous artists in the province while increasing public access to art.

Through the Artist in the Schools and ArtsSmarts programs we have also been connecting artists with schools. Artists are an essential resource for teachers and can provide direction and assistance as schools implement the Arts Education Curriculum. Through these efforts, we are working to create more opportunities for the arts to have an impact on people in their communities and in their day-to-day lives.

In 2004 the Arts Board began a review of its strategic plan. A key part of this process involves visiting communities across Saskatchewan and having conversations about what the arts mean to you, your family and your community. By the end of 2005 we will have a new plan that will direct our programs, services and goals for the next three years. It will not just be a plan for the Arts Board, but an expression of the vision we all share for the arts in Saskatchewan.



Saskatchewan Talent Takes the Stage at Canadian Western Agribition

In November the Saskatchewan Arts Board, in partnership with Canadian Western Agribition, presented a series of readings by Saskatchewan authors called *Writing Home*. 2004 was the second year of a partnership between the Arts Board and Agribition, established as part of our ongoing commitment to profile the accomplishments of Saskatchewan artists.

Writers Bonnie Dunlop of Swift Current, Chris Fisher of Lumsden, Judith Silverthorne of Regina, Sharon Butala of Eastend, and Bill Robertson of Saskatoon gave readings in the Grandstand throughout the seven-day event. Judith Silverthorne gave a special noon hour reading of her book *Dinosaur Hideout* to school groups.

The Arts Board also presented the Friday night rodeo audience with a performance by Buffalo Boy Productions. Buffalo Boy Productions is a high energy dance group featuring traditional regalia, song and dance that reflects part of the Indigenous heritage of Saskatchewan.

The Living Skies Festival of Words presents programming for people of all ages including author readings, performances by singer-songwriters, interviews and workshops. A strong promoter of the literary arts, the Festival of Words celebrates the imaginative uses of words by entertaining and enlightening readers and listeners.

Far and Wide was the theme for the 2004 Saskatchewan Festival of Words. Writers from Vancouver Island to Newfoundland and Labrador were featured with Saskatchewan literary talent and international authors, including Rohinton Minstry.

The Festival of Words has gained recognition as one of the must-attend literary events in the country and has helped to promote the community of Moose Jaw as a key tourist destination and thriving cultural centre.

Saskatchewan Dancer Travels to Brazil

Graham Kotowich, a young Métis dancer from Regina, received an Individual Assistance award to travel to Brazil to participate in dance competitions and workshops. While there Graham competed in two international dance competitions and attended numerous workshops with highly acclaimed teachers in ballet, jazz, modern dance, tap and flamenco.

This experience allowed Graham to have his work recognized on an international level and further develop his practice.

Provincial Cultural Organization Brings Soap Stone Technique to Youth at Risk

In January 2005, with support from a Cameco Caring Community Grant, the Saskatchewan Craft Council worked with Kilburn Hall Youth Centre staff in Saskatoon to conduct a soap stone sculpture event for youth at risk. Two professional sculptors took six boys through the process of creating their own unique works of art from the initial stages of cutting the soap stone to the finished pieces. Many of the youth involved expressed pride in their finished pieces, and a desire to do more. The event was so successful that the Youth Centre is considering adding craft activities to their regular programming.

Broadview High School Drama Club Explores Way Back When

The Broadview High School Drama Club received an ArtsSmarts grant to work with Regina theatre artist Michele Sereda to develop a collective creation based on the theme "Way Back When". The project involved the high school drama club, community drama enthusiasts and First Nations partners in exploring the history of the town of Broadview and the farming and Indigenous communities nearby.


The mission of ArtsSmarts is to encourage schools and communities to integrate arts-related activity into the school curriculum and to encourage young people to develop their intellectual skills through active participation in the arts. Building partnerships that link young people, artists, arts organizations, schools and communities is fundamental to ArtsSmarts as a key tool to encouraging youth participation in the arts.

Organization of Saskatchewan Arts Councils Explores Issue of Bullying with Saskatchewan High School Students

In February 2005 the Organization of Saskatchewan Arts Councils presented the play The Shape of a Girl by Joan MacLeod to eight high school audiences in Kipling, Regina, North Battleford, Bienfait and Estevan.

The Shape of a Girl is based on the story of British Columbia teenager Reena Virk and the real-life tragedy of her murder by a group of teens. It is a dramatic one-woman show that explores the realities of teenage relationships with insight and honesty.

The subject of bullying is an important issue in elementary and secondary schools across the country. The shows performed in Regina high schools were booked by guidance counsellors as a way of addressing the bullying issues in their own schools. Theatre makes a strong impact and as part of the process a study guide was provided to schools prior to the performance. Teachers were encouraged to use this as a tool in their class rooms.

Art Rental: The Affordable Makeover Solution for Your Office!

The Arts Board's Permanent Collection is the single largest collection of Saskatchewan art in the world. Through this program over 455 works are placed on display in public places throughout Saskatchewan providing people with the opportunity to experience the Permanent Collection first hand.

The Art Rental Program is an affordable way to revitalize office environments. Friendly and experienced Arts Board staff are available to help clients select art work that complements their workspaces. Art Rental clients have access to a variety of art work including paintings, drawings, textiles, prints, photographs and sculptures from some of Saskatchewan's best-loved artists.

Saskatchewan's Film and Television Industry Bring Art to Work

As part of the *Art At Work* initiative Saskatchewan Communications Network (SCN), Saskatchewan Motion Picture Association (SMPIA) and Birdsong Communications hosted visual artist Heather Cline in a five-month residency.

Heather worked closely with employees from the three businesses to develop a new understanding of the creative process. She held a variety of workshops and classes, drop-in sessions and open studio time. The theme for the project was the communications industry in the province. Workers took part in art making activities like printmaking, painting, collage, box and relief construction, video, and exploration with traditional and found materials.

One of the main priorities for each of the employers in this residency was to include and engage all staff, from the people working in finance and administration to the technical and programming staff. Providing these opportunities in the workplace encourages creativity and develops stronger, more robust communities.

PART OF WORK

In 2004 the Art At Work initiative was implemented by the Saskatchewan Arts Board, in partnership with the City of Regina and the Cultural Capitals of Canada program in celebration of Regina's designation as the Cultural Capital of Canada. As part of this program ten Regina workplaces recruited ten professional artists to animate their organizations with the goal of helping staff experience art in the workplace while developing an array of unique and transferable skills.

The MacKenzie Art Gallery: Calling Black Lake

Calling Black Lake is a long-distance educational project connecting students living in Black Lake to students in Regina. It was started as part of the MacKenzie's Urban Outreach Program for Regina inner-city schools and on-reserve schools. Calling Black Lake started as a small project with two groups of students- from Father Porte Memorial Dené School in Black Lake and Campbell Collegiate in Regina- mailing one another visual art and photographs as a way of getting to know one another.

As additional funding was acquired, the MacKenzie was able to expand the program by involving two artists in residence, Sheila Orr and Gabriel Yahyahkeekoot, and two educational programmers, Damon Heit and Blayne George. The MacKenzie was also able to incorporate two artist visits to the community of Black Lake.

All of the student's photography, videos and paintings will be featured in a MacKenzie exhibition scheduled for the fall of 2005. The exhibition will be presented as a Discoveries in Art! school tour in the fall of 2005.

The MacKenzie Art Gallery's Urban Outreach Program is a community effort that has received funding from a wide range of organizations including Alliance Pipeline, Conexus Credit Union, the Royal Bank Foundation, the City of Regina, the Government of Canada and the Canada Council for the Arts. Past funders of the program include Casino Regina, Farm Credit Canada, and SaskEnergy.

Artist Works with Patients, Staff and Volunteers in the Regina Qu'Appelle Health Region

Through the *Artist in Residence* program the Regina Qu'Appelle Health Region hosted artist Bonnie Chapman to work with patients, clients, staff and volunteers in a mind, body and spirit approach to art making.

Bonnie worked to create a safe space where participants could become absorbed in their own creative process as a way to alleviate the anxiety, boredom, pain, depression and stress that are often part of the institutional experience.

Chapman worked with a wide range of people during this residency, providing activities such as bedside art programs to Oncology Pediatrics at the Pasqua Hospital, and the Renal Unit at the Regina General Hospital. Studio classes were offered to parents with babies in the Neonatal Intensive Care Unit, and long-term care residents at the Wascana Rehabilitation Centre.

Indigenous Leaders Rebuild Links to Cultural Heritage

In 2004 the Adoption Support Centre of Saskatchewan received funding through the Aboriginal Arts and Cultural Leadership program to provide Indigenous adoptees with the opportunity to express themselves through traditional art in an effort to rebuild links to their cultural birthright.

Their goal was to have cultural leaders connect Aboriginal adoptees to their ancestral roots through a variety of art activities including drum making, drumming, traditional singing, dance and expressive writing. Throughout the program participants sat with Indigenous leaders in the community, listened to their stories, heard their music, danced with them and learned about their culture.

PARIOF OURIDENTITY

The Aboriginal Arts and Culture Leadership program develops Aboriginal leadership in arts and culture at the individual, group and community levels. The program builds capacity in Aboriginal communities through the development of art and cultural leaders. This program is supported with funding from the Community Initiatives Fund. The Arts Board is contracted to administer and manage the jury process.

Louise Halfe Named Saskatchewan's New Poet Laureate

In February 2004 Lieutenant Governor Dr. Lynda Haverstock announced that Louise Halfe of Saskatoon would be Saskatchewan's new Poet Laureate.

Louise, also known by her Cree name, Sky Dancer, was born in Two Hills, Alberta and was raised on Saddle Lake First Nation. She has written two acclaimed books of poetry and her work has appeared widely in anthologies and periodicals.

The Saskatchewan Poet Laureate Program was initiated in 2000 and is the first provincial program of its kind in Canada. The program is funded by the Saskatchewan Arts Board under the patronage of the Lieutenant Governor, the Honourable Dr. Lynda Haverstock and is administered by the Saskatchewan Writers Guild in partnership with the Saskatchewan Arts Board and the Saskatchewan Book Awards.

92-Year-Old Indigenous Artist Considered a Cultural Treasure by her Community

Flora Weenonis is a 92-year-old Indigenous artist who has been creating for most of her life. She learned the art of basket-making and beading from her mother and grandmother and continues to make baskets in the old style as well as beaded articles like moccasins, jackets and gauntlets.

Flora lives in the small community of Victoire, Saskatchewan and, like many from her community, Cree is her first language. Her work reflects the cultural and artistic traditions of her people and her ability to pass them on to younger generations is highly valued by other Northern Cree peoples working to preserve the old ways.



Brundibár Opera Commemorates the End of World War II

The year 2005 marks the 60th anniversary of the end of World War II and the liberation of detainees from the Nazi concentration camps. In October, the Brundibár Organizing Committee received a Project Assistance award to join forces with the award winning Saskatoon Children's Choir and professional Saskatchewan artists to present performances in Saskatoon and Regina in the spring of 2005.

Brundibár was written by the Czech Jewish composer Hans Krása in 1938. In 1942, he was deported to Terezín, a ghetto town created by the Nazis to amass European Jews. In Terezín, Brundibár was performed more than fifty times by children and musicians living in the ghetto. During the rehearsals and performances, as the transports were in progress, there was a constant stream of new performers, replacing the previous performers who were being shipped to Auschwitz for extermination.

The production of Brundibár is a project of artistic, historical and social significance. It will bring to life the horrors of the Second World War while highlighting the encouraging message that even in the face of death, hope lived on for those facing the terror of the war.

Permanent Collection


The Permanent Collection is the largest single collection of work by Saskatchewan artists. Started in 1950 as a way to preserve the history of contemporary visual art practices in our province, the Permanent Collection has grown to include over 2,300 works by 590 artists from all across Saskatchewan. Like other Arts Board programs and initiatives, the Permanent Collection brings locally produced art into the lives of Saskatchewan people while supporting Saskatchewan artists and creating a cultural inheritance for the future.

As part of our commitment to bring art into the everyday lives of Saskatchewan people, the Arts Board supported a variety of *Working with Art* exhibitions featuring work from our Permanent Collection. This exhibition was on display at the Mayor's Inaugural Art and Business Luncheon in Regina, the Premier's Dinner in Saskatoon and was also featured as part of YWCA Regina's 2005 Women of Distinction celebrations.



paved Art and New Media is an artist run centre for production, presentation, research, and dissemination of contemporary paved arts. The word "paved" is an acronym that addresses the different art forms covered under the organization's mandate: photography, audio, video, electronic and digital.

Artist Invites People to Try Their Luck

In October 2004 Saskatoon-based visual artist Cindy Baker received an Individual Assistance award to undertake an innovative project that incorporates elements of play and pop culture and encourages spectator participation.

Cindy's inspiration was the popular television game show *The* Price is Right, which she describes as "an amazing spectacle, and a chance to start over again" for the lucky contestants. Cindy constructed a mini-portable set, where she invites the public to 'play' while she investigates how the game changes depending on the audience and the location they are playing

New Media Organization Acts as a Valuable Resource for **Local Artists**

In the spring of 2004 paved Art and New Media collaborated with Tribe Inc. to present an interactive internet based event called Cyber Pow Wow: Unnatural Resources. In this project community members were invited to log into a combination chat space, virtual gallery and library where they could explore issues of contemporary Indigenous art, technology and community.

The New Hip Hop: Saskatchewan Artists Take the Mic

Prince Albert based producer and hip hop artist Justin Knight received an Individual Assistance award to write, compose and record a compilation album of original music. Hip hop is a collaborative art form with artists working together to create completed works that are a mixture of sound, poetry and rhythm.

Hip hop is a movement that began among culturally diverse youth in urban centres. In recent years Hip Hop has become very popular in Saskatchewan, thanks to the support of artists like Justin Knight and programs like Common Weal's Prairie Roots program, which offers workshops and performances by local artists.

One-Man Band Builds Songs in Front of Live Audiences

Dave Taylor is a Regina-based musician and producer. In 2004 he received an Individual Assistance award for an innovative recording project that introduced audiences to a new way of thinking about music. His project involved producing a ten-song album in a recording studio then performing it live, fully arranged, as a one-man band. The live process was unique as he recreated each individual sound in front of an audience to demonstrate the different layers of sound in each song.

Music often goes through various stages before it reaches its final form. This project has successfully made the process of building a song visible to an audience.




Pauline Whitehead received an Indigenous Bridging Arts award to gather oral histories from the Indigenous elders of the Saulteaux nations in the communities of Yellow Quill, Kinistin, Fishing Lake and other Saskatchewan First Nations.

The emergence of artists such as Pauline and organizations like Saskatchewan Native Theatre Company has resulted in a renaissance in Saskatchewan theatre based on First Nations stories and traditions with Indigenous artists involved in every facet of production.

The Bridging Arts Grant program was created to increase participation and access to public funding by Indigenous artists in the province, and to act as a bridge between Indigenous arts and other Arts Board programs.



Jack Pine Press showcases Saskatchewan literary and visual art talent by providing writers and artists a place to publish collaborative chapbooks The press often publishes work by emerging artists, providing new talent the important experience of a first publication.

Jack Pine Press: A Small Press Produces Big Books

Tower Road by Saskatchewan poet Barbara Klar was published by Jack Pine Press as a new title in 04/05. The book consists of four poems about fear, fire, loss, and walking in the lodge-pole pines of the Cypress Hills. Like most chapbooks the visual art component is as strong as the writing with each copy featuring original black and white photographs and other visual surprises that guide the reader through the text. Tower Road was written, designed, and contains images by Barbara Klar and is as interesting as an art object as it is a riveting piece of literature.

Jack Pine Press releases in 2004 include diverse titles like The Departure of the Name by Miranda Traub, Five Ways to Lose Your Way by Don McKay and Tower Road by Barbara Klar.

Saskatchewan Artists Honoured at the Lieutenant Governor's Arts Awards

The inaugural Lieutenant Governor's Arts Awards were held in Saskatoon's Kinsmen park under a big top tent in spring 2004. A crowd of over 300 were treated to a barbeque of Saskatchewan cuisine and were wowed with performances by singer Eileen Laverty and master of the Métis fiddle, John Arcand who performed with dancers Jeff and Rejean Soucy.

In addition to being a performer at the event, John Arcand was the recipient of the prestigious Lifetime Achievement Award. John is an accomplished composer, musician and instructor of the Métis fiddle and dance who has spent his life preserving and promoting these traditions. His passion and dedication to promoting traditional Métis music has had an enormous impact on the entire province. For his

Maria Campbell Awarded the Canada Council for the Arts Molson Prize

In the spring of 2004 Métis artist and professor Maria Campbell was awarded the Canada Council for the Arts Molson Prize.

Maria is one of the first Aboriginal, writers, playwrights, theatre producers and filmmakers in Canada. She started her career in 1973 when she published her autobiography, *Halfbreed*. The book has become a literary classic and continues to be one of the most widely taught texts in Canadian literature. Maria has also written four children's books, stage and screen plays and founded her own film and video production company. She is one of the treasures of our province and is highly respected as an artist, an elder, a community leader and a teacher.

Recognizing the Achievements of Our Artists

The Saskatchewan Arts Board is committed to promoting the value of the arts and the work of artists in our province. One way of accomplishing this goal is by supporting awards that recognize the achievement of the arts community.

These awards generate pride in Saskatchewan talent and provide the recipients with support and recognition for their work.

Two Molson Prizes worth \$50,000 each are awarded every year to distinguished Canadians, one in the arts and the other in the social sciences or humanities. The prizes recognize the recipients' outstanding lifetime contribution to the cultural and intellectual life of Canada.



Lea Rose Nakonechny received an Individual Assistance award to assist with the production of her film, *Two Museums*. The film, shot entirely in 16mm film, is the first-ever theatrical film about contemporary life in rural Saskatchewan. This visually stunning documentary follows two prairie women through four seasons as they defend their choice to remain in rural Saskatchewan. Set against the enchanting landscape of southwest Saskatchewan, this film captures the Saskatchewan experience in an entirely unique way.

In 2005, Lea Nakonechny paired *Two Museums* with Brian Stockton's short film, *That's My Wonderful Town*, to present a tour to theatres across the province as a way to celebrate our province's centennial.

Dancing Sky Theatre to Bring New Play to Saskatchewan Communities

Dancing Sky Theatre of Meacham has been contracted to create, produce and present a new play for a tour of Saskatchewan during the summer of 2005 in honour of the Centennial. Dancing Sky's vision for this project is to create a piece that truly celebrates the one thing that we all share in Saskatchewan: this place and this land. The play titled *All My Relations- Wahkotowin* will incorporate, where ever possible, the natural landscape of each of the 50 or more communities it is performed in. The script is a collaboration between Dancing Sky, a collective of performers, and senior Saskatchewan artists Trevor Herriot and Maria Campbell.

To reach a wide and broad audience performances will be free and will take place in community venues including parks, libraries, exhibitions, fairs, Saskatchewan homecoming events and community celebrations. In recognition of our 100th anniversary, Saskatchewan Centennial 2005 designated \$250,000 in funding for the creation and tour of an original theatre production, and contracted the Saskatchewan Arts Board to oversee the project. Following a peer jury process, Dancing Sky Theatre was selected to create this artistic legacy.


Air Ronge Artist Selected to Design and Paint New Mural

Roger Jerome, a Métis artist who lives in Air Ronge, was selected to design and paint the 2005 Saskatchewan Centennial Mural. The mural will be installed in the rotunda in the Saskatchewan Legislative building and will be a key architectural highlight for years to come.

Drawing and painting has always been an important part of Roger Jerome's life and his subject matter often includes portraits, northern scenes and traditional events. The mural, titled *Northern Tradition and Transition*, depicts the waterways and highways that were central to the development of the North.

The painting will be installed in the rotunda of the Legislative building, and unveiled by Her Majesty Queen Elizabeth II as part of her visit to Saskatchewan in May 2005.

Management Responsibility for Financial Information

Management discharges its responsibility for financial information under the stewardship of the Board and its Audit Committee. In accordance with Article 28 of The Arts Board Act, 1997 the Board's financial statements are audited annually by the Provincial Auditor or any other auditor or firm of auditors appointed by the Lieutenant Governor in Council. The Audit Committee is available to meet with the designated auditors as required.

NOTES TO THE FINANCIAL STATEMENTS

March 31, 2005

1. Purpose and Authority

The Saskatchewan Arts Board was established pursuant to *The Arts Board Act*. It has been continued under *The Arts Board Act*, 1997 (the Act). It exists to cultivate an environment in which the arts thrive for the benefit of everyone in Saskatchewan. The Act continues the Saskatchewan Arts Board Fund through which all financial transactions are conducted which pertain to fulfilling the purposes of the agency as indicated in the Act.

2. Significant Accounting Policies

The Saskatchewan Arts Board uses Canadian generally accepted accounting principles appropriate for public sector. The significant policies are as follows:

a) The Basis of Accounting

The financial statements are reported on the expense basis of accounting.

b) Collections

The Board maintains a collection of artworks and related archives in all forms in order to inform, enlighten, and enhance the lives of present and future generations. Works in the collection are acquired through purchase, commission, donation, or bequest.

- i) Permanent collection purchases are charged at cost as an expense in the Statement of Operations and Accumulated Surplus in the year of purchase.
- ii) Donated works of art and archives for the permanent collection are recorded as revenue at their fair market value at the time of donation with a corresponding charge to expenses in the Statement of Operations and Accumulated Surplus.
- iii) Musical instrument purchases are charged at cost as an expense in the Statement of Operations and Accumulated Surplus in the year of purchase.

c) Tangible Capital Assets

Leasehold improvements, equipment, and furnishings are recorded at cost less accumulated amortization. The net book value of these capital assets is detailed in Note 4(a). Net book value of leasehold improvements is determined by using the straight-line amortization method over the life of the lease and one renewable term. Net book value of equipment and furnishings is determined by using the straight-line amortization method, with an estimated residual value of 10% of cost. Equipment and furnishings are amortized as follows:

Electronic equipment 4 years
Other equipment 6 years
Furnishings and fixtures 10 years
Leasehold improvements 10 years

d) Designated Assets

Internally - the Board periodically designates amounts from cash to be allocated for specified purposes. In designating these amounts, the Board takes into account the amounts and stated preferences of contributors. These amounts are not available for other purposes without approval of the Board.

Externally - the Board may receive cash with the stipulation it be used for specific purposes. These amounts are available only for the purposes stipulated by the contributor.

e) Grant expenses

Grants are expensed when approved by the Board, the applicant has met the eligibility criteria and the amount of the grant can be estimated.

f) Cash

Cash consists of interest-bearing money on deposit with the bank. The interest rates range from 1.75% to 2.25% (2004 - 2.016 to 3.00%)

During the year the Board purchased works of art for the permanent collection totaling \$34,765 (2004 - \$49,945). In addition, there were \$7,850 (2004-\$0) works of arts donated to the collection. In January 2002, the permanent collection was appraised by members of the Professional Art Dealers Association of Canada and assigned a value of \$2,903,173 on the basis of market value.

4. Tangible Capital Assets

a) Equipment and furnishings

During the year the Board acquired capital assets of \$151,653 (2004 - \$35,213). No capital assets were disposed of in 2005 or 2004. As a result no gain or loss on disposition was incurred in either year. Capital assets are comprised of the following amounts:

b) Land

In July 1998, Order-in-Council 485/98 authorized Saskatchewan Environment to sell, and the Board to acquire, provincial lands identified in the Order-in-Council for the total value of \$1. The current market value of the land has not been determined as of the issuance of the financial statements.

5. Designated Funds

a) Internally Designated Funds

In 2005, the Board designated \$5,828 from cash (2004 - \$0). The total of amounts designated and allocated by the Board collectively earned interest of \$2,955 (2004 - \$3,369). The Board disbursed \$0 from these funds in 2005 (2004 - \$409). The comparative year-end allocation balances are as follows:

b) Externally Designated Funds

In 2004, the Board received \$215,000 from the Provincial Secretary (a related party) for the 2005 Centennial Mural project. As at March 31, 2005, the Board had recognized \$130,276 into project revenue for costs incurred on the project. Also in 2004, the Board received \$30,000 from the Provincial Secretary for the Prince Edward Drama Scholarship Fund. During the year, the Board allocated \$662 interest to the Fund and did not disburse any funds from it.

During the current year, the Board received \$180,000 from the Department of Culture, Youth and Recreation (a related party) for the 2005 Saskatchewan Centennial Theatre Tour project. During the year, it recognized \$180,000 into project revenue for costs incurred.

6. Pension Plan

Employees make contributions to the Public Employees Pension Plan, a defined contribution plan. Funding requirements are established by *The Superannuation (Supplementary Provisions) Act*. Rates of contribution were unchanged during the year at 5% of gross salary from employees and 6% from the Board. This plan is fully funded. During the year the Board's total contributions were \$46,575 (2004 - \$38,889) and are included in Salaries and benefits in Note 13.

7. Related Party Transactions

All Government of Saskatchewan agencies such as departments, corporations, boards and commissions are related since all are controlled by the Government. These financial statements include transactions with other Government agencies.

8. Financial Instruments

10. Loans Receivable

In 2002, the Board entered into a loan agreement with a non-profit organization in the amount of \$150,000. In 2004, the Board entered into a second loan agreement with the organization for an additional amount of \$115,000 and amended the repayment terms of the first loan. The interest rate on both loans is set at prime less two percent. During the year, the Board entered into another loan agreement with another non-profit organization. The Board advanced \$19,000 in the current year and an additional \$39,500 was advances subsequent to the year end. The interest rate on this loan is 3.5%. Future payments to the Board, pursuant to these agreements and including the repayment of the additional \$39,500 advanced subsequent to the year end, are as follows:

11. Protocol Agreement

During the year, the Board entered into a standing partnership agreement with SaskCulture Inc. regarding responsibilities for jointly delivered programs, including principles involving the assessment and funding of provincial cultural organizations. In 2005, the Board recommended funding of \$1,795,535 (2004 - \$1,717,733) to be paid to 9 organizations (2004 - 8). Since these payments are made directly by Saskatchewan Lotteries Trust Fund for Sport, Culture and Recreation they are not reported in these financial statements.

12. Trust Moneys

In 2002, the Board entered into an agreement with the Minister of Culture, Youth and Recreation, which names the Board as recipient and administrator of provincial contributions to The Arts Stabilization Fund. As the agreement stipulates, the Board receives and pays out the full amount of contributions the Minister shall pay to The Arts Stabilization Fund. During the year, the Board received and paid to The Arts Stabilization Fund the provincial government's contribution of \$125,000 (2004- \$0). As these funds are not subject to the discretionary authority of the Board, they are not reflected in these financial statements.
